## SELF-REPRESENTED LITIGANT MOTION & ORDER FOR CONTINUANCE

## This form is intended for litigants who:

v' Have a hearing or other matter set before the court, commissioner and/or a hearing officer and wish to have that matter continued until a future date.

## <u>Information you will need:</u>

- 1. The docket number of the case for which you are requesting a continuance.
- 2. The date and location of your currently scheduled hearing.
- 3. Evidence (if possible) in support of your request for a continuance.
- 4. The exact name and address of the opposing party or the opposing party's counsel.

## **Instructions:**

These instructions are meant to guide you through the process of requesting a continuance. Note that courts take scheduled dates seriously, and a continuance should be asked for only as a last option. Filing a Motion for Continuance does not automatically mean you will be granted a continuance. If the court does not grant it, the case will move forward according to the already scheduled date.

Motions to Continue hearing officer conferences are discouraged.

(24<sup>th</sup> JDC Rule 24.1 B(5)) If the Motion for Continuance is contested by the opposing party, you should ask for a hearing so that you can explain to the court in person why the motion should be granted.

When you represent yourself in court, you must follow all the proper procedures and the law. It is your responsibility to see your case through the whole process.

- 1. Be sure you have the correct form.

- 3. Fill in the blanks with 100% accurate information- any false statement made in court or written in a court document may constitute perjury.
- 4. Check all options that pertain to your situation.
- 5. Attach any supporting documentation (i.e. a doctor's note) related to your request.
